**BREAKFAST MEAL PRICE INCREASES FOR 2014-2015:** Motion was made by Mr. Tackett and seconded by Mr. Southwell that the Board approve raising the student breakfast meal from \$1.25 to \$1.50 beginning in 2014-2015. Staff breakfast meals will go from \$1.50 to \$1.75, and guest meals will go from \$1.50 to \$2.00. (Info on file) Motion carried with 5 ayes and no noes.

<u>LUNCH MEAL PRICE INCREASES FOR 2014-2015</u>: Motion was made by Ms. Camp and seconded by Mr. Tackett that the Board approve raising the student lunch meals by \$.10 at each campus to stay in compliance and raise adult meals by \$.25 for the 2014-2015 school year. (Info on file) Motion carried with 5 ayes and no noes.

CONSIDER OUT OF STATE TRIP FOR THE BRUCE JUNIOR HIGH BAND AND THE BRUCE JUNIOR HIGH AVID CLASS: Motion was made by Mr. Southwell and seconded by Ms. Camp that the Board approve the out of state trip for the junior high school band to Hot Springs, Arkansas on Friday, May 16, 2014. (All information on file) Motion carried with 5 ayes and no noes.

ADDITION TO THE 2013-2014 HIGH SCHOOL STUDENT HANDBOOK: Motion was made by Mr. Tefteller and seconded by Mr. Southwell that the Board approve an immediate change to the Gilmer High School Student Handbook.
