PUBLIC HEARING TO DISCUSS THE 2013-2014 PROPOSED TAX RATES

The hearing was opened at 7:23 PM for questions, comments or clarifications. James Still and Phillip Williams both had questions. The hearing closed at 7:27 PM.

Motion was made by Mr. Tackett and seconded by Mrs. King that the Board approve the consent agenda items "#'s A, B and F" by general consent action as recommended. (All item information on file) Motion carried with 4 ayes and no noes.

REGULAR AGENDA ITEMS:

MOTION TO ADOPT TAX RATE RESOLUTION ON JULY 15, 2013: The motion was read aloud. The Ordinance to set the tax rate was read aloud. Motion was: I move that the property tax rate be increased by the adoption of a tax rate per hundred dollars valuation of \$1.17 for Maintenance and Operations (M&O), of \$0.145 for Interest and Sinking (I&S), for a total rate of \$1.315, which is effectively a 8.49 percent increase in the tax rate, and furthermore, that if a majority of voters approve the \$1.315 total tax rate in a tax ratification election, in order to reduce the I&S tax rate by \$0.13, that the property tax rate be increased by the adoption of a tax rate of \$1.17 for Maintenance and Operations, of \$0.015 for Interest and Sinking, for a total rate of \$1.185, which is effectively a -2.24 percent increase in the tax rate. This tax rate will raise more taxes for maintenance and operations than last year's tax rate. The tax rate will effectively be raised by 12.24 percent and will raise taxes for maintenance and operations on a \$100,000 home by approximately \$130. This motion is understood to adopt the attached Ordinance.

Motion was made by Mr. Skinner and seconded by Mrs. King that the Board of Trustees of the Gilmer ISD set the tax rates to be as follows:

M & O Tax Rate \$1.17 I & S Tax Rate \$0.145 Total Tax Rate \$1.315;

The Board of Trustees of the Gilmer ISD sets the proposed rates for publication of the Second Notice of Public Meeting to discuss Proposed Tax Rate to be held on July 15, 2013 at 6:00 P.M. to be as follows:

M & O Tax Rate \$1.17 I & S Tax Rate \$0.015 Total Tax Rate \$1.185;

And as a result of this action, the Board of Trustees of the Gilmer ISD intends to call a Tax Ratification Election on September 14, 2013.

ORDINANCE TO SET TAX RATE

| Date: July 15, 2013 |

| On this date, we, the Board of Trustees of the Gilmer Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year <u>2013</u> at a total tax rate of \$ <u>1315</u> , to be assessed and collected by the duly specified assessor and collector as follows: |
| \$1.17 for the purpose of maintenance and operation, and |
| \$_0.145 for the purpose of payment of principal and interest on debts; |
| furthermore, if voters approve the total tax rate of \$_1.315\$ in a tax ratification election , in order to reduce the debt rate by \$0.13, we hereby levy or set the tax rate on \$100 valuation for the District for the tax year $_2013$ at a total tax rate of \$_1.185, to be assessed and collected by the duly specified assessor and collector as follows: |
| \$1.17 for the purpose of maintenance and operation, and |
| \$_0.015_ for the purpose of payment of principal and interest on debts. |
| Such taxes are to be assessed and collected by the tax officials designated by the District. |
| THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. |
| THE TAX RATE WILL EFFECTIVELY BE RAISED BY 12.24 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$130. |
